ALL SSP STUDENTS ARE PAIRED WITH FINANCIAL SPONSORS WHO OFFER FINANCIAL SUPPORT AND MENTORS WHO PROVIDE ONE-TO-ONE MENTORING, THUS MAKING A MEANINGFUL IMPACT ON THEIR LIVES.
